Dear Member,

Thank you for your interest in Benton REA's window rebate program. Your conservation effort will help to reduce your electric bills and will also help (a little) to reduce regional energy use. A couple of things to know before the ball starts rolling: (1) To qualify, electric needs to be your primary heating source. (2) Make sure your window contractor is aware of and participating in our window program.

The program is designed to replace windows and sliding glass doors that are single pane, single pane with storm windows or units that are double pane with metal frames. Replacement windows must have a u-value that is .30 or lower. Sliding glass doors must have a u-value of .35 or lower. Our rebate is three dollars per square foot of glazing area. So, for a 4 x 5 window (20 square feet), the rebate would be \$60. There is also a slightly higher rebate available if you wish to install windows that have a u-value that is .22 or lower. Benton REA does not offer rebates for new windows that are larger than the ones they replace. You may find that federal tax credits will also apply by visiting [energystar.gov/index.cfm?c=products.pr\\_tax\\_credits](http://energystar.gov/index.cfm?c=products.pr_tax_credits).

Please notify me before the job begins and make sure your contractor files paperwork with Benton REA detailing the installation plan. It would be prudent for you to confirm that he or she has done so. After the work is complete, your contractor is required to file with Benton REA a copy of your invoice that specifies the glazing units that were installed. I have also included the form that you fill out for our records that confirms that the contractor completed your project. When these steps are complete, Benton REA will issue your rebate.

Some homeowners might be interested in doing the window replacements themselves and they should contact me to find out the steps for doing so.
