## Benton REA Member Insulation Rebates

You may calculate your customer's rebate by multiplying the square footage of the insulated space by the appropriate rebate amount according to this table. A pre- and post-inspection performed by a Benton REA representative is required to receive the rebate.

Insulation Location	Starting Insulation Level	Final Insulation Level	Rebate Amount Per Square Foot
Attic	R0-7	≥ R38	\$0.65
Attic	R8-11	≥ R38	\$0.25
Attic	R12-19	≥ R38	\$0.10
Attic	R20-30	≥ R38	\$0.04
Attic	R31-38	≥ R49	\$0.02
Floors	R0-11	R19	\$0.25
Floors	R0-11	R25/30	\$0.30
Walls	R0	≥ R11	\$0.65

## Contractor Air-Sealing Rebates

Incentives for whole-home air sealing are based on the reduction of the air volume moving in and out of the home – this is measured in cubic feet per minute (CFM) and determined through a blower door test conducted by a Benton REA representative before and after air-sealing. Benton REA will pay a rebate of **\$0.20/CFM** to the air-sealing contractor.
